

Full ccNSO Process according to the Rules of the ccNSO (2004)



Worst scenario: 66 days*

Rejection Action Petition Period 21 days

ccNSO has the opportunity to submit a petition – 21 days

ccNSO receives a petition(s)

Council rejects petition

Council accepts petition

10 % of ccNSO members call for ratification

ccNSO members vote too late: no decision

Rejection Action Petition Support Period 7 days

ccNSO seeks support from other DPs – 7 days

Other DP submits a petition – 7 days

NO support from Council

Council supports the petition

No time for ratification call



Potential ccNSO Decisions During Rejection Action Community Forum Period








Final ccNSO Rejection Action Decision
