# Short introduction to the webinar

# Background – IANA on the move from US Gov?

US regulator NTIA (National Telecommunications and Information Administration) announced on March 14, 2014 that the supervisory stewardship of IANA today convened by US regulator NTIA might be transferred to the global internet community.

IANA functions contract comprises:

- Domain Names
- IP-addresses
- Protocols

may in the future be supervised by the Global Internet Community

# 4 key elements of any transition proposal

The NTIA has indicated that the transition proposal must have broad community support and address the following four principles:

- Support and enhance the multistakeholder model;
- Maintain the security, stability, and resiliency of the Internet DNS;
- Meet the needs and expectations of the global customers and partners of the IANA services; and,
- Maintain the openness of the Internet.

# Who was selected as ccTLDs reps in CWG

- On the 8th September there was a call for volunteers to participate in the Cross-Community Working Group to Develop an IANA Stewardship Transition Proposal on Naming Related Functions.
- 9 candidates applied and the ccNSO Council selected
- ccNSO members:
  - Erick Iriarte (.pe, LACTLD,) Vika Mpisane (.za, AFTLD,) Staffan Jonson (.se, CENTR)
- Non-ccNSO members
  - Lise Fuhr (.dk, CENTR), Paul Kane (.ac, CENTR and APTLD member)

# Why and what is CWG?

- The ccNSO Council adopted the charter for the Cross-Community Working Group (CWG) to Develop an IANA Stewardship Transition Proposal on Naming Related Functions.
- The charter sets the framework for the CWG.
- CWG consists of 103 people (19 members and 84 participants) – everyone can be participants.
- Jonathan Robinson and Lise Fuhr represent naming community (vice chairs)
- The ccTLD members of the CWG should consult with ccTLD Managers, identify themes and draft a ccTLD requirements documents for discussion in the CWG.

- III. Proposed Post-Transition Oversight and Accountability Arrangements
- IV. Transition Implications
- V. NTIA Requirements
- VI. Community Process
