"During this past year, the GRC Rules Subgroup has worked on the important task of drafting revisions to the [ccNSO Rules](#).

Leading this effort has been a pleasure thanks to the thoughtful contributions of the [Subgroup members](#), observers, and ICANN staff support team: Irina Danelia, Stephen Deerhake, Chris Disspain, Atsushi Endo, Ann-Cathrin Marcussen, Alejandra Reynoso, Katrina Sataki (Observer), Sean Copeland (Observer), Bart Boswinkel (ICANN), Kim Carlson (ICANN) and Joke Braeken (ICANN).

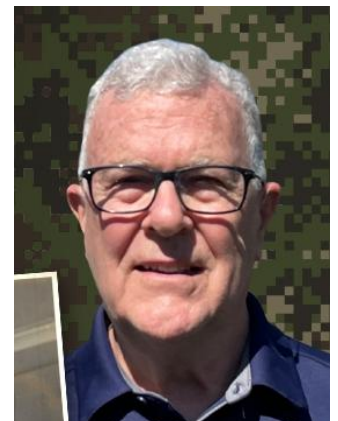
We recognized that our task was not wholesale revision of the Rules but rather a modest update. Having taken into account ccNSO community input and the practices of ccNSO over the 18 years since the Rules were adopted, we are about to forward a draft recommendation for the ccNSO members that, in our view, maintain the cogency of the original Rules.

The Subgroup has added context to the Rules by creating an introduction and a restatement of the ccNSO Principles (both of which are intended as context – not as Rules themselves); we added a glossary; a clear indication of which decisions are for Council and which for members, and which of Council's decisions are subject to member veto; we call for periodic review of the Rules; and, in an important change we suggest adjusting the quorum for membership votes, reducing it to a more realistic number in view of the growth of ccNSO membership. Of course, the final vote on the new Rules will be subject to the currently existing quorum requirements.

We hope that our suggestions will be accepted, and the team members are prepared to help encourage active membership participation in a vote.

It has been a privilege to chair this Subgroup."

"I still remember how we started this Committee: so full of hopes to complete the work within two years. Our main task was to review the current guidelines, identify potential gaps, and propose updates. "How hard could it be?", we reasoned. Somehow, this simple little task grew bigger and bigger almost by day. Now, six years later, it feels that the amount of work hasn't shrunk a bit. Partly it can be explained by the need to prepare the ccNSO as a Decisional Participant to all the processes that are envisioned in the Bylaws with respect to the Empowered Community, partly – by the fact that the ccNSO grows and evolves and, thus, the existing documents need to be periodically reviewed and updated.

One of the hardest challenges for the GRC is to strike the right balance between the need to keep documents reasonably short and yet provide a sufficient level of detail. Another aspect that the GRC is paying a lot of attention to is to the structure of the guidelines and the language used in the documents. One of the first things we agreed upon was the uniform structure of the documents to make it easier for the reader. We also keep in mind that the majority of the participants in the ccNSO are not native English speakers, therefore, guidelines must be written in plain English.

Today, the GRC is on the path of transforming into a better version of itself. The work of the GRC will form the core of the continuous improvement of the ccNSO. The recent success of the GRC sub-group tasked with the update of the Rules of the ccNSO, paves the path towards a new approach to the way the ccNSO is governed to serve the ccTLDs around the globe." "The ccNSO Strategic and Operating Committee (SOPC) has proven to ICANN how much ccTLDs can contribute to improving and refining the ICANN processes. It was the time when ICANN started to work more on their planning and to introduce regular consultations with the various community constituencies. It was the dawn of the adult era of ICANN.

The SOPC definitely contributed to the way the current Plans are designed and structured, with timelines, deliverables, Key Performance Indicators and an overall more streamlined comment process.

As SOPC Chair for several years, I am happy to have been one of the drivers of the transformation of the SOP working group into a permanent Committee, to have received so many acknowledgements of SOPC's work by other constituencies, to see the SOPC modus operandi become best practice.

I leave a more mature Committee with great members who have a sound expertise in looking after strategies at their own ccTLD level and, thanks to that, have the capacity to be pillars for the ICANN planning process. I did not use the word "pillar" by chance as now the ICANN Plans are quite monumental documents! 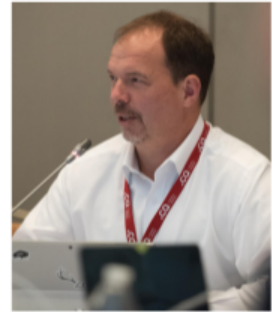

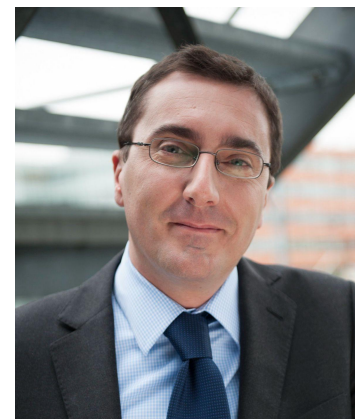

Changes since March 2021

"I have loved my role as ccNSO Councillor, the always constructive discussions, the richness that comes from the members' diversity, the true spirit of cooperation that is at the basis of any action, the acknowledgement that united we can achieve higher objectives.

Being a Councillor is not a line in the CV. It is a role that comes with duties and responsibilities. It is a role that implies a regular commitment to following the various discussion threads on many topics, to read the long and not-so-long documents that are shared on the Council list in preparation of the meetings. It is a role that needs some devotion so as to remain awake late in the evening to attend meetings (now that



we are all Zoom-addicted) or to stay late in the meeting room when others are getting ready for the gala or music night. I played this role with honesty, passion and modesty because I know that I want to continue to learn.

I still remember when ICANN first began organising the ccNSO meetings. The Italian registry, .it, was the one of the two organisers of the ICANN Rome meeting, back in 2004. The ccNSO convened its first large meeting there. Internet cables were all over the room as wifi was the exception at that time, not the rule. 17 years have passed since the ICANN Rome meeting. "I had the invaluable opportunity to be a ccNSO Councilor elected by the NomCom and it has been a great experience for the last 3 years. I have had the opportunity to work and interact with people from all over the world, which is priceless. This work required me to familiarize myself with topics while adapting to different working methods used at the ccNSO. It was really very interesting to have the opportunity to participate in different working groups and at the same time work with people who are experts in ccTLDs in their respective countries.

One of the committees I participated in is the IGLC (Internet Governance Liaison Committee), where we discussed the latest Internet Governance issues from the ccTLD perspective and created a heat map of the most important Internet Governance topics in the world, divided by the different regions. This gives us an overview of what's happening in the world and also allows us to provide the ccTLD world with the latest news.

There is also a lot of work going on behind the scenes to prepare for the ICANN meetings, which requires a lot of effort from the various working groups, and the result is something the ccNSO can be proud of. If you belong to the ccTLD world and have the opportunity, I strongly recommend you to join the ccNSO, as a Councilor, or just by attending the different working groups or committees, believe me, it will be one of your best experiences." Nigel Roberts looks back on his term as ccNSO appointed members on the ICANN Board of Directors:

"Towards the end of 2021 I completed a three-year term as your ICANN Board Member. During that time I served on the Audit Committee, the Technical Committee, Risk Committee, the Strategic Planning Committee, and Chair of the Board Accountability Mechanisms Committee.

Serving as your Board Member was a privilege and a joy. It also comes as a cost - whilst the time commitment is not overly onerous, it is nonetheless fairly significant. Increasing responsibilities elsewhere (both work and personal) sometimes have to take priority no matter how much one is having fun. I'm 100% confident that we will be well-served with Patricio and Katrina, going forward.



The role of an ICANN Board Member has changed over the last 20 years. There is a creative tension between appointing professional NEDs (non-executive directors) without industry specific knowledge (and they then learning about ICANN and the multi-stakeholder model on-the-job), and appointing senior people from within the community and supporting them with the necessary skills and training to be effective NEDs. ICANN is remarkable at giving the opportunities it gives for training to its Directors. It probably has the balance about right, but there will be challenges for the Board going forward.

I'm incredibly proud to have been one of the people who helped build ICANN and the Multistakeholder Model after the International Forum on the White Paper in 1998, and to have been a long-term contributor in various roles, including serving on the ccNSO Council for a number of years prior to joining the Board.

I shall be taking a step back for a few months, but I am sure we will meet again at some future event, once the world situation permits. Oh, and one more thing, I wish you all a successful and happy 2022." (Nigel Roberts - Outgoing ICANN Board representative)
