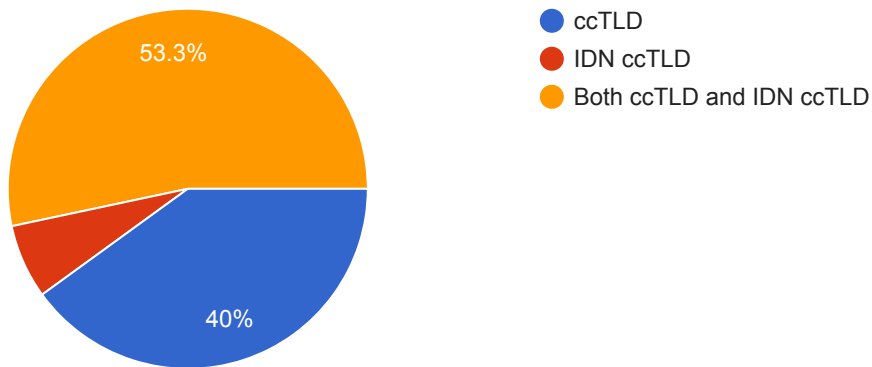

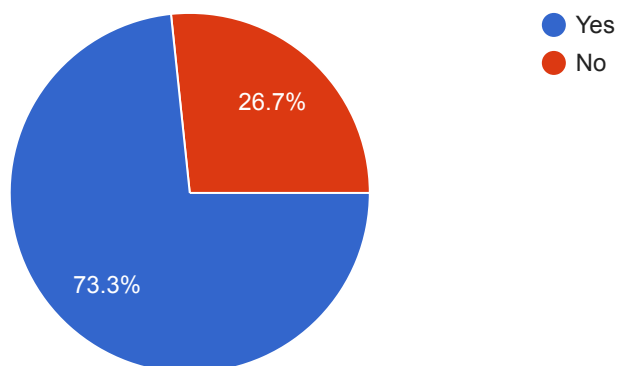

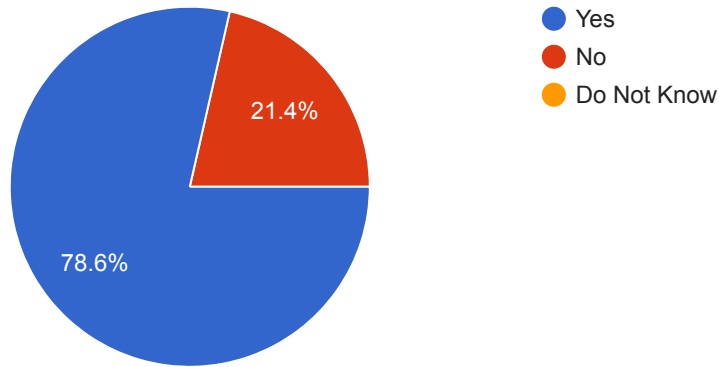
### Are You a member of ICANN's Country Code Name Supporting Organization (ccNSO)?

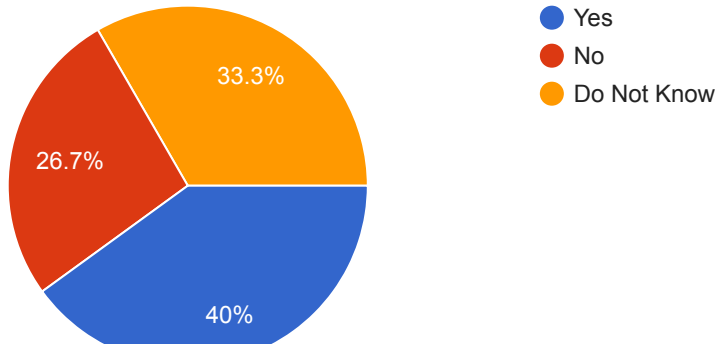

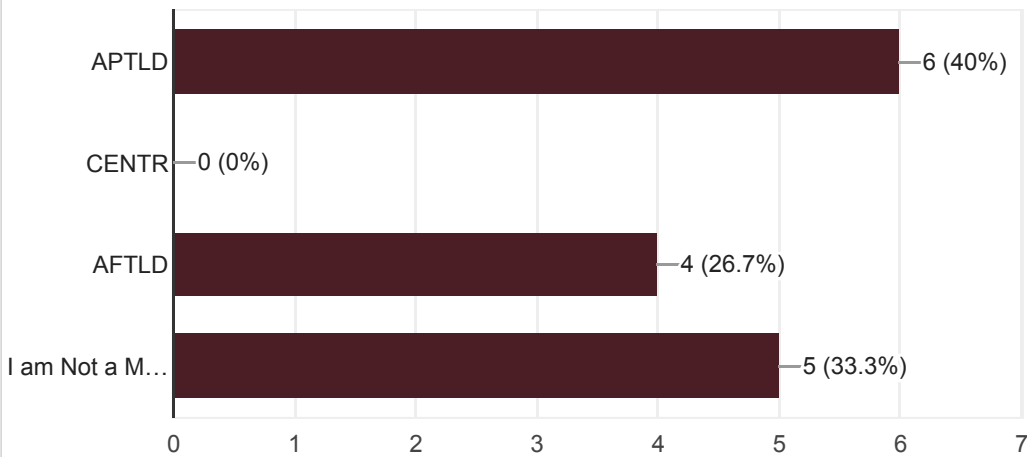

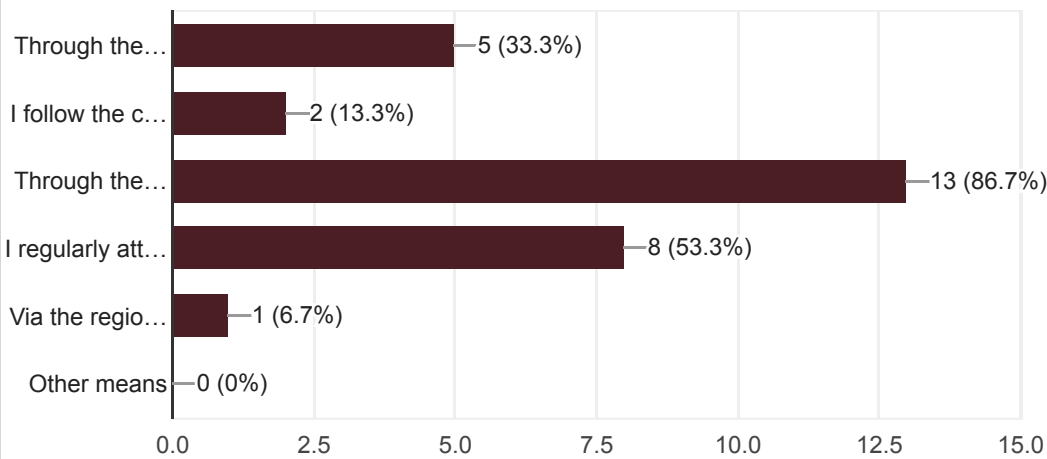

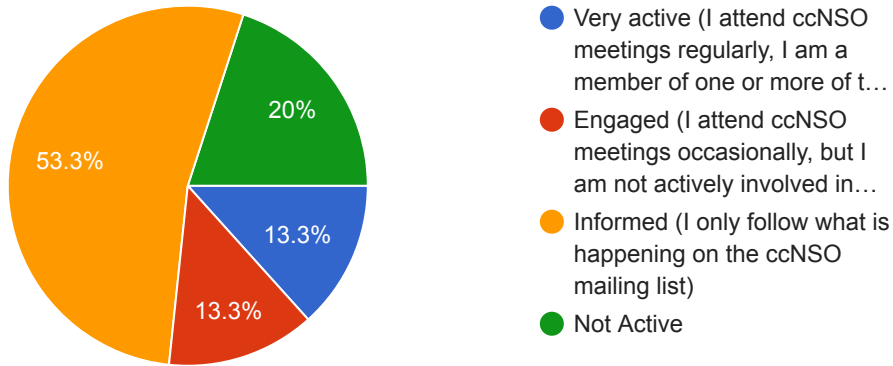

5. How would you rate your engagement level with the ccNSO and the global ccTLD community?

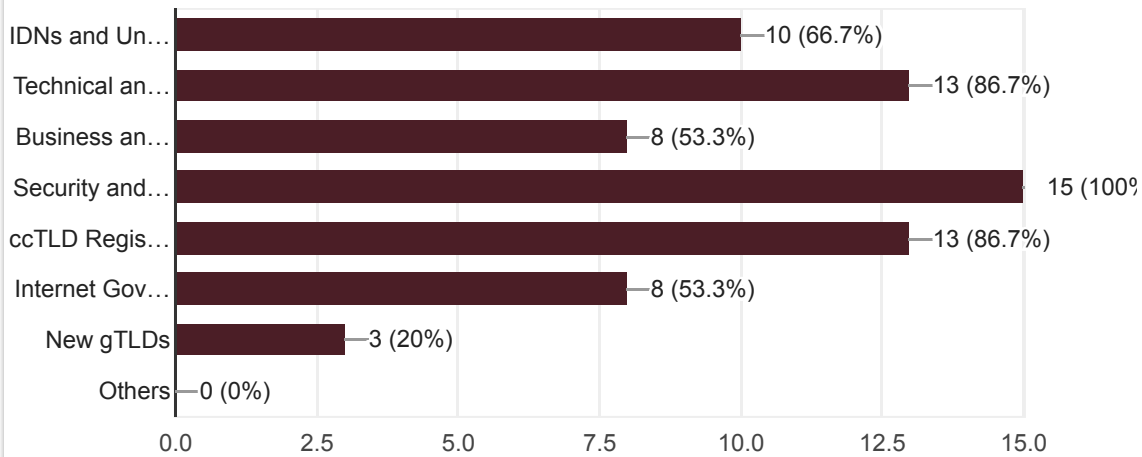

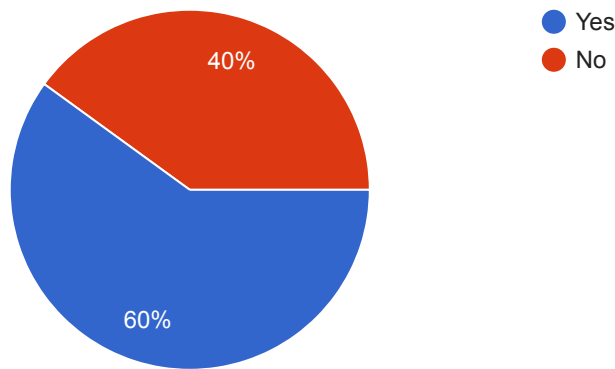

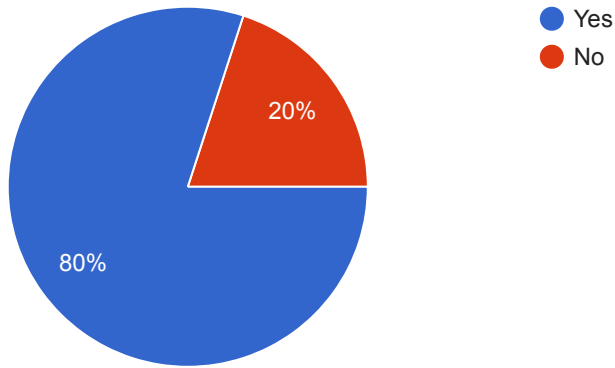
DNSSEC, Security, promoting registrations under ccTLD
