Dear ccNSO members, colleagues and friends,

This is for the second time that I am requesting for your support of my nomination for a new term on the Council.

Whilst my first term on the Council was an exciting journey that has enriched me with new knowledge and competencies, I would like to seize an opportunity to translate thus gained experience to continue serving the ccTLD community in the ICANN environment in the most constructive and efficient manner.

If re-elected, I will focus on implementing ccNSO strategy in the following areas:

- ensuring ccNSO contribution to ICANN's broader work to advance ccTLD perspectives and interests and keep ICANN transparent and accountable;
- supporting ccTLD-related Policy development and implementation;
- prioritizing ccNSO activities to ensure efficient use of community resources, timely response to the incoming requests.

Background

In addition to being a ccNSO councilor, I currently am Vice-chair of Strategic and Operational Planning Standing Committee (SOPC), member of Guidelines Review Committee (GRC) and Triage Committee, I'm representing the ccNSO on ICANN Planning Prioritization Process.

Together with SOPS Chair Andreas Musielak I work on enhancing the efficiency of SOPC processes. We aim to ensure ccTLD community input is taken into consideration in ICANN planning and budgeting processes.

I contributed a number of recent ccNSO achievements such as new ccNSO Rules approval, ccNSO Purpose and Goals (Strategy) and Workplan development, Statement of Interest and Conflict of Interest concept, Implementation guidelines development.

I also was a member of two recent PDP working groups (PDP3 on Review Mechanism WG and PDP4 WG on (de-)selection of IDN ccTLD strings).

At the ccNSO Council I was engaged in ad-hoc groups to respond to incoming requests and provide input to broader ICANN processes.

I have used every opportunity to share my expertise and promote ccNSO and the multistakeholder model at global, regional and local industry and community events.

My three years on the ccNSO Council let me fully understand the way it operates and allowed me to refine skills necessary to contribute to processes underpinning the ccTLD community's engagement, in its unique role, with the broader multistakeholder community

If becoming a Councilor, I will do my best to ensure that every voice is heard and every note is responded to. I will be truly honored to serve this community.
