Statement :

Dear ccNSO members,

I am very grateful to my fellow colleagues in the Asia Pacific region who have faith in my leadership and proposed & seconded my name as a candidate for the ccNSO council to serve ICANN through council.

With support of member countries, I am recently nominated at leadership position in ccPDP4 work group.

After 36+ years of experience in the Indian Telecom sector as Government bureaucrate and serving in various roles and 12 years of experience on the Board of National Internet Exchange of India (NIXI), I have taken over as Chief Executive Officer (CEO) of NIXI.

NIXI has been one of the active members of ccNSO handling 16 TLDs including 15 IDNs in 22 languages. NIXI, as representative of Government of India, have played a crucial role in the Neo-Brahmi Generation Panel (NBGP) meant for developing Root Zone Label Generation Rules (LGR) in scripts being used in India and neighboring countries.

ccNSO plays an important role in nurturing consensus across the ccTLD community relating various issues concerning ccTLDs, and in making policy recommendations to ICANN Board. The

major challenge for the ccTLD community is to build up secure and stable ccTLD service through collaboration at the global level.

In this bottom up multistakeholder approach, our Asia region which has the highest internet user base and with next billion of users also expected to come from this part of the world, our involvement is much critical in shaping the future of the internet and its policies in the world.

Along with you, I have planned to contribute on issues related to ccNSO community and not limited to:

- i. New gTLD :
 - Procedures and subsequent rounds should consider and safeguard the interest of the ccTLD community.
 - Using NBGP (neo Brahmi Generation Panel) experience to work for IDN new gTLD.
- ii. DNS abuse :best practices and capacity development to mitigate the abuse.
- iii. IDNs : with 15 IDN TLDs, India is best placed to help other countries to work around development of IDN strategy.
- iv. Universal Acceptance: in Asia, IDN ccTLD use non ASCII characters. So work for Universal Acceptance with all the Asia Pacific members.

Work in close coordination with other SOs and ACs with the aim of engaging with the broader community.
