3. Significantly Interested Parties

- 3.1.BS noted that it was agreed on our last call to change the title of section 3 to properly reflect the status of the GAC Principles. BT confirmed this would be done in the next version.
- 3.2.BS noted that the origin of the document in section 4 titled Understanding Delegation and Re-delegation was no longer part of the document. I was generally agreed it should be included in this version of the document.
- 3.3.Section 7.1.1 BT noted he had not been able to contact BB to work on this text and had inserted some new draft text. It was generally agreed that this new text was not adequate. BT will contact BB and review.

BT confirmed that this was an issue but was uncertain the text proposed by BS was the best solution and that he would look into this.
