#### 23 September 2014

#### From the ALAC/ccNSO Liaison September report by Maureen Hilyard

- **1.** The ccNsO Council have been very occupied with activities that have overtaken much of other SO and AC agendas at this time, namely:
  - The IANA Stewardship Transition Process and appointments of members to the CWG
  - Progress of the ccNSO Coordination Committee
  - Updates on progress with ICANN's Accountability process and the adoption of the ccNSO public comment on process design
  - The Selection of ccNSO participants in the ICANN leadership training
  - Comments were requested of the ccNSO community on the ATLAS II Declaration

# ALAC Statement on the Proposed Bylaws Changes Regarding Consideration of GAC Advice

#### **Summary**

- 1. The ALAC salutes the Board's continued effort on the implementation of the ATRT1 and ATRT2 recommendations, specifically recommendation 11 of the ATRT1 and 6.5 of the ATRT2.
- 2. Notwithstanding, the ALAC is concerned that the proposed Bylaws changes regarding consideration of GAC advice by the Board may derive in an unbalanced weight to the GAC's advice compared to that of the other ACs or the policies proposed by each of the SOs.
- 3. Moreover, the ALAC observes a trend in the Internet Governance ecosystem that tends to push towards giving increased power to governments. The proposed Bylaws changes regarding consideration of GAC advice would add to this trend that we consider undesirable.
- 4. Considering that the BGRI has already designed a "Process for consultations between the [Board] and the [GAC]," the ALAC calls the Board to reconsider the proposed bylaws changes and continue to foster equal footing among all participants of the ICANN community.
- 5. If the Board is to implement this Bylaw change, the ALAC advises the Board to fully implement recommendation 9.1 of ATRT2 in the same round of Bylaw changes. This would preserve the delicate balance of advice coming from the ALAC, SSAC and RSSAC alongside the GAC.
- 6. The ALAC is confident that the Board will continue to implement the recommendations of the ATRT1 and ATRT2 in a way that safeguards the principles of the multi-stakeholder model, more specifically those that help bring balance among participants.

### Summary of the three above statements:

- **1**. At-Large has taken note of the many new gTLD Registries' Registry Services Evaluation Process (RSEP) requests applying for exceptions to Specification 5, Section 2 of the New gTLD Registry Agreement.
- **2**. Many of the RSEP requests are for the release of two character ASCII labels not on the ISO 3166-1 alpha 2 standards. However, the ISO 3166-1 alpha 2 standards will be updated to reflect changes to countries and territories. Future countries and territories may be consequently treated differently than those on today's ISO 3166-1 alpha 2 list.
- **3**. Furthermore, two character ASCII labels at the second level have been made available for some gTLDs and many ccTLDs.
- **4**. Absent any DNS-related security or stability issues, the ALAC believes that all the restrictions of two character ASCII labels at the 2nd level within a TLD should ultimately be removed, and has no problem with the current exceptions being approved.
